# MINUTES OF THE MEETING OF SHAWBURY PARISH COUNCIL HELD IN THE VILLAGE HALL ON TUESDAY JANUARY 13<sup>TH</sup>. 2015 at 7.00pm.

# **Public Session:**

Ten members of the public were in attendance and complained strongly about possible restrictions being placed on owners exercising their dogs on the playing field. Chairman explained that Shropshire Council had approved orders covering areas used by children and the Parish Council were discussing how these should be activated in the parish. Increasingly some irresponsible owners were allowing dogs to foul public areas and there was a need for action to be taken.

Members of the public suggested that irresponsible owners needed training and advice and the Chairman promised that the Council would support any sensible proposals they could make.

The issue would be debated in full at the next Council meeting.

# 14/131 Minutes of Meeting held on December 9<sup>th.</sup> 2014:

#### 14/132 Matters Arising:

#### (a) Highways (14/115(a))

There were reports of little progress being made on issues which had been reported to Shropshire Council.

# (b) White Lodge Park – speeding traffic (public session).

A response had been received from Mr. David Gradwell stating that he would attempt to get additional signs put in place when the extended 30mph signs were being erected on the A53 and would include the placement of speed retarders in the Parish's road safety requests for 2015 - 2016.

# (c) Speed Watch Project (14/115(b)).

Clerk reported that the article in the Parish Magazine had resulted in one additional volunteer, which brought the total to four. As there was a requirement for a minimum of seven volunteers, it was not possible to apply to participate in the scheme. It was decided to defer any action for the time being.

# (d) Dog Control Orders (14/119):

An article had been published in the Parish Magazine outlining the suggestions proposed at the last meeting and stating that possible orders would be discussed at the February meeting of the Council. Shropshire Council's Dog Orders had been sent to Members and there was a need to study them in detail and take account of the feelings of the dog owners who had attended in the public session.

It was noted that the Clerk had received one letter of support for any action the Council decided to take. (e) Youth Provision (14/125(c):

Shropshire Councillor Simon Jones explained that a sub-committee of the Local Joint Committee had met and were issuing a consultation document suggesting that the money available should be used to employ a field worker to set up Youth Clubs in Shawbury and Wem and give advice and support to rural areas.
