SHAWBURY PARISH COUNCIL MINUTES OF THE COUNCIL MEETING HELD IN THE VILLAGE HALL ON TUESDAY OCTOBER 10TH. 2023 at 7.00pm.

Public Session:

Three members of the public were in attendance, with two of them stating that they wished to object to the proposal to name the playing field Queen's Park. The Chairman said that the proposal was being considered at Item 4 on the Agenda and assured them that their objections to the proposal would be noted.

The third person confirmed that he had attended the previous meeting and had stated his objections to the plan and wished to see what action was being proposed.

23/84Apologies:

Apologies were received from Councillors Ms. S. McIntosh and Mr. K. Pickering and Flt/Lt. J. Jones (RAF Shawbury).

23/85 Disclosure of Personal or Prejudicial Interests.

No interests were declared.

23/86 Minutes of Meeting held on September 12th. at 7.00pm.

The minutes of the meeting having been circulated were approved and signed by the Chairman as a true record.

23/87 Matters Arising.

(a) Up-grading VAS Units (23/74(a)):

The Clerk reminded Members that they were unable to spend precept money on this type of project and there was only sufficient money in the CIL budget to pay for one unit and as the current Units are attached to streetlights maintained by Shropshire Council, there would be a need to consult with their Officers. It was also pointed out that the up-graded lights had to be regularly monitored by local volunteers.

As a result it was decided to defer any decision until Shropshire Council published the review they were undertaking but the Clerk was asked to contact the Police Commissioner to see if any grants were available to help to improve road safety.

(b) Proposal to Re-Name the Playing Field (23/74 (b)):

The Chairman stated that in view of the adverse reaction to the suggested plan from local residents, he proposed that the Council should not proceed with any further discussion and that the plan should be abandoned. The proposal was seconded and there was a unanimous vote supporting this.

(c) Street lights (23/74(c)):

It was noted that the £3,795 from Scottish Power for previous over-charging had finally been credited to the Council and thanks to the advice from Jason and Elaine at Shropshire Council, the Parish Council has joined the Shropshire Council Consortium. The future power for street lighting will cost £4,361.00 per annum +VAT (£1,090.25 per quarter +VAT).

The payment for the power from March 2022 to October 2023, which has not been invoiced by Scottish Power has still to be resolved and could cost in the region of £7,500 (+VAT) but £10K has been 'ring fenced' to cover this.

(d) Environmental Maintenance Grant (EMG).

It was agreed to employ JST Services to continue with the programme of path clearance and related activity. The Clerk reported that local residents had reported a number of paths that needed clearing and he would pass on the details to JST.

(d) Allotment (23/74(d)).

Clerk reported that as no plans had been produced it was now necessary to complete a new application for the shed. It was agreed to delay any further action until the next meeting as it appeared that plans were being prepared.

23/88 Correspondence.

(ii) Streetlights:

No issues raised.

(iii) Other:

The following items were raised and approved:

- (a) The purchase of a new waste bin for the Burial Ground as the current bin had been vandalised.
- (b) The annual rent for housing the Parish Defibrillator to be increased from £25.00 to £35.00.
- (c) A donation of £100.00 to be made to the Church funds after the next burial, in acknowledgement of the support being given by the Church Warden.
- (d) As promised and when received, the historical records of the War Memorial to be given to the Church for retention and public display.
- (e) The Council would pay for the repair of the recently damaged Floral Gateway.

23/91 Playing Field Fencing Posts:

Councillor P. Sharp reminded Members that when the original hedge surrounding the playing field had been removed, it had been decided to replace it with the current set of posts, which were designed to prevent access to the field by unwanted vehicles. These posts were all rotting away and being replaced by similar ones which would only have a limited life span. This was an expensive operation and there was a need to consider alternative methods of protecting the field. Two Members agreed to meet with him to consider this in more detail and report back at the next meeting.
