18/145 Apologies

18/146 Personal or Prejudicial Interests.

Councillor C. Kirkup declared an interest in Item 14 on the agenda.

18/147 Minutes of Meeting held on November 13th. 2018.

The minutes of the meeting, having been circulated, were approved and signed by the Chairman as a true record.

18/148 Matters Arising.

(a) Car Park Fencing (18/131(b).

Clerk reported that following a meeting with the contractor a revised quotation of £5,170.86 had been received now including the erection of a new bench and metal protectors for the base of all the posts. The quote had been approved by the Chairman and Vice-Chairman and Mr. Mark Blount (Shropshire Council) had agreed that the project could be financed using money from the Poynton Road project grant.

It was hoped to start the work after the school holidays and it would take a week to complete. Members supported the decision.

(b) Playing Field Gate notice (18/135iii (2))

Clerk reported that he had discussed this with Mr. Luke Wilson and it had been agreed that he should leave the gate open whilst he was working on site.

(c) Environmental Maintenance Grant (18/135iii (6))

It was agreed that the Clerk should contact Mr. Simon Brown at Shropshire Council to see if this money could be used to finance the replacement/repair of the road name plates.

18/151 Financial Statement.

18/152 Budget:

After discussion and clarification, the budget was unanimously approved and it was decided not to increase the precept set at £51,250.00 for the next year. 18/153 Exchange of Information:

(a) Agenda Items for next meeting:

Continued drainage problems at the junction of the A53 and Wytheford Road, even though some remedial work had been undertaken.

Need for the replacement of all the road markings at the junction of the A53 and Church Street and leading up to the crossing.

(iii) Oher:

(a) Meeting Dates for 2019.

It was confirmed that meetings would continue to take place on the second Tuesday of each month and that the Annual Parish Meeting would be held before the start of the Council meeting in May. It was decided that there would be no call this year for nominations for the Community Support Award.

18/154 Reports from:

(a) Police:

The Chairman welcomed P.C. L. Heathcote to the meeting and he informed Members that he had been moved to the Wem area to take over from Dave Carpenter who had recently retired from the force. He gave a brief outline of his duties and the area he had to cover. Having been stationed in Wem as a

support officer he had a good working knowledge of the area and the problems associated with it. He would be working closely with other agencies and welcomed contact from the Council.

(c) Car Park Fencing:

Mr. M. Blount had agreed that the replacement of the car park bollards could be financed from the Housing Development Grant. See Minute 148(a)

(d) Junior Football pitch:

It was reported that the Football Club were hopeful that the lease would be agreed before Christmas.
