#### 13/143 Litter Picking.

During the preparation of the budget for 2014 - 2015, concerns had been raised that the Council was spending about 12.5% of the precept on picking up litter. Investigations had indicated that we were duplicating work that should be carried out by Shropshire Council and that some areas in the contract were no longer needed. A paper had been produced suggesting that there was a need to completely review the service.

After detailed consideration it was decided that there was no need for the current system and that the current contract with Mr. Creber should be cancelled at the end of the current financial year – March 31<sup>st</sup>. As he was paid a month in advance the final payment to him would be made at the March meeting. At the next meeting there would be a full review of the service needed in the future.

Clerk to inform Mr. Creber of the decision.

# 13/144 Budget and Precept Setting 2014 – 2015.

Members considered a draft budget presented by the Clerk and after due consideration this was approved following the amendment to the budget for litter collection.

Clerk reported that as part of his contract Richard Bailey had agreed to cut the grass in the play area on the playing field.

#### 13/145 Glebe Area Developments

Clerk reported that he had received the grant of £5,000.00 from the Diocese as a contribution to the cost of the paths and the grant of £1,782.00 from the LJC for the picnic tables and seats. A meeting of the committee had agreed where these should be sited once they were delivered.

It was agreed that the urgent need in the Glebe area was to get all the old fencing, barbed wire, etc. and c removed before the spring and complete any necessary drainage work. Clerk to discuss this with Mr. Bailey. Once that was complete other issues could be addressed.

It was suggested that a holiday/weekend project could be arranged for children to build and put in place nest boxes, etc.

Clerk reported that Mr. Dove had contacted him and was arranging to transfer the money held by the Angling Club into the Council's account.
