# 16/01 Declaration of Personal or Prejudicial Interests.

## 16/02 Minutes of Meeting held on March 8th. 2016

The minutes of the meeting, having been circulated, were approved and signed by the Chairman as a true record.

# 16/03 Matters Arising:

## (a) Highways (15/169(a))

There was no evidence of work being carried out on issues which had been raised over the past few months.

# (b)) Moat Sign (15/169(c))

Members congratulated the Vice -Chairman on the standard of the excellent sign she had arranged to have erected.

## (c) Council vacancy (15/169(d)).

Clerk reported that Mrs. Sheila Pallant had declared an interest and hoped to be able to sit in at the next meeting to see what was involved.

# (d) Vehicle Activated Signs (15/169(e)).

It was unanimously agreed to:

- 1. Delay a decision on the location of a sign at Edgebolton, based on the difficulty in finding a suitable location and a report from the Safer Road Partnership stating that the majority of vehicles were observing the limit. Response from the public at the Annual Parish Meeting would be considered.
- 2. To accept a quotation from EON to erect a 30mph sign on the streetlight close to the Farm Shop. The cost would be £3,220.00 (+VAT). Clerk to liaise with Mr. Jason Hughes and Mr. David Gradwell (Shropshire Council) and Mr Garry Johnson (EON).

# (e) Fitness Area (15/169(f))

Councillor P. Sharp reported that the Council had secured a grant of £8,000 from Tesco and the Clerk stated that a grant of £5,000 had been promised by the Hilton-Jones Charitable Trust. The total cost of the proposed project was £18,000 but the VAT could be re-claimed leaving the Council to provide about £2,000, which had been budgeted for from events that had taken place at various times. It was agreed to go ahead with the development and meet with the contractor to finalise the plans. (f) Group Awards (16/169(h)).

Recipients of the award had been informed and invited to attend the Annual Parish Meeting to receive their plaques. It was agreed that the Chairman should make the presentations.

#### 16/08 The Burial Ground

Councillor Mrs. Medley gave an excellent report on the planned lay out of the extended burial ground and pointed out that there were still several spaces in the original ground. There were sufficient spaces to provide for burials over many years.

Members approved the document and she was thanked for her efforts.

She also pointed out that there was several areas of remedial work needed and the Chairman agreed to discuss this with Richard Bailey and ask him to carry out the work.

#### 16/09 Reports From:

# (a) Police

No report tabled.

## (b) RAF Shawbury.

## Lt. McArdle reported that:

60 Sqn Centenary Event was being celebrated on April 29<sup>th</sup>.

Land Owners Day was on May 19th.

Building was now under way for the new development and did not appear to be causing too many problems.

# (c) Shropshire Council.

Shropshire Councillor Jones reported that:

- 1. Repairs to the Millbrook/Bridgeway roads was not in this year's funding programme.
- 2. Resurfacing and drainage problems by the traffic light area were planned to take place this year.
- 3. Contrary to press reports there were no major cuts planned to bus services.
- 4. The Government had provided extra finance to deal with the County's pot hole problems.

Councillor Sharp questioned Councillor Smith over details of Shropshire Council's funding plans that had been presented at a recent SALC Committee meeting. It appeared that a whole range of services could be withdrawn if agreement could not be reached by September for Parish and Town Councils to take responsibility for them. It seemed to include items such as highway maintenance.

In response Councillor Jones stated that Shropshire Council were looking at different ways in which services could be delivered and would be discussing these with town and parish councils. There was a need for Shropshire Council to have overall responsibility for statutory services but other service might have to be withdrawn if alternative providers could not be identified.

#### 16/09 Planning:

A.The following applications had been received and were considered:

- 1. Wytheford House, Wytheford- installation of 165KW combined heating power unit to replace gas powered system. *Application supported*.
- 2. Bridgeway erection of a single storey outbuilding for use as a garage and home gym area. Application supported but planners asked to check the distance between the new build and the boundaries.
- 3. 'Cauldersytch Cottage' Butlers Bank erection of a detached dormer bungalow annexed to existing dwelling. *Application supported*.
- 4. Four Winds, The Green, Shawbury replacement dwelling. *Application supported*.
- B. The following application had been approved by Shropshire Council:
- 74, Bridgeway  $1^{st}$  floor extension, garage conversion, extension to rear.

## C. Other:

# Development alongside the A53.

Chairman reported that he had been asked to sign a paper agreeing to the proposal that part of the cost of providing a roundabout on the A53 for the new housing development should be charged against the CIL money. It was expected that final plans would be published in the near future.
