**22/47 Apologies:**

Apologies were received from Councillors Mr. C. Kirkup; Ms. S. McIntosh and Mr. P. Sharp and from F/S. M. Lingham (RAF Shawbury).

**22/48 Disclosure of Personal or Prejudicial Interests.**

No interests were declared.

**22/49 Minutes of Meeting held on June 14<sup>th</sup>. 2022.**

The minutes of the meeting having been circulated were approved and signed by the Chairman as a true record.

**22/50 Matters Arising.**

(a) Street Lights (22/34(a)).

It was noted that there had been no response from Scottish Power and no work had been carried out on the outstanding development in Bridgeway and Millbrook. There had been no reply to emails sent to Mr. Garry Johnson at E.ON

(b) Burial Ground (22/34(b)).

Councillor K. Pickering had provided the Clerk with a list of materials required to carry out necessary improvements to the burial ground. The overall cost would be £169.00 and this was approved and he agreed to carry out the work on a voluntary basis.

(c) Road Name Plates (22/24(22/24(c))).

No further problems had been reported and Cllr. P. Sharp had agreed to order the replacements for those that had originally been reported and ask JST to carry out the replacement work.

(d) Playing Field. Fencing Posts (22/24(d)).

Cllr. P. Sharp reported he had supported JST in removing seventeen posts and replacing them with new ones and it was agreed that the work had been completed in a very professional way.

(e) Community Speed Watch Project (22/24(e)).

It was reported that notices had been placed at a variety of locations round the Parish and included again in the Parish Newsletter and on the Council web site. There had only been interest shown by one member of the public and this meant there were still not sufficient volunteers to enable the project to take place.

(f) Allotment

Members considered items included in the purchase transfer document which had been raised by the Council's solicitor and confirmed that they supported the outlined condition of sale. The Clerk was asked to confirm this with the Solicitor and ask for the sale to proceed.

(g) Moat Seating – grass cutting (22/41).

Nobridge Ltd. Had agreed to include this work with their current programme at a cost of £50.00 per cut. The first cut has been carried out and another visit planned for the first week in August. It was noted that the work was of a high standard.

b) The financial statement for July was tabled and approved.**22/53 Review of outstanding Highways Issues.**

Members considered a report sent to Shropshire Council in November 2020 outlining a range of Highway maintenance issues which had been reported and not been resolved. An assurance from the Highways Department had been received stating that the issues raised would be dealt with. However in spite of that assurance several issues had still not been resolved and Shropshire Councillor S. Jones asked for details of the outstanding items and promised to investigate them.

**22/54 Exchange of Information.**(a) Agenda Items for next meeting.(b) Issues Needing Attention:i Highways:

Regular flooding by the new roundabout with the drains appearing to be unable to cope when there is reasonable rainfall.

Problems with a number of gullies especially one on the A53 close to River Gardens.

iii. Other Reports.

An email had been received from Cllr. C. Kirkup on behalf of Shawbury United Football Club stating that the Club would like to hold a Chariot Race on the field in order to raise some money for the Club.

The request was considered but it was felt that there was insufficient information available for a decision to be made. The Clerk was asked to respond pointing out the type of information required and the request would be considered again at the next meeting.

**(c) Shropshire Council:**

Councillor S. Jones reported that:

1. There were new regulations regarding the control Shropshire and Telford & Wrekin Councils had over the local NHS service.

2. The public inspection of Shropshire Council's Housing Plan was underway. It had started at Shrewsbury Town's Football Club but because of an outbreak of Covid was continuing by Zoom. The general public were welcome to take part in the proceedings.

3. There would be careful consideration of the Telford CSE Inquiry which had just been published.

3. Covid numbers across the County were increasing again.

1. Land adjacent to 122 Church Street – erection of two detached dwellings, vehicle access and parking areas plus removal of some trees (22/02557/FUL).

2. Jayroc Stables, Shawbury Heath – the erection of a horse walker (15m diameter) isolation unit and extensions to the existing agricultural building. *A 'No Comment' response was made.*
